

## **Application Form for Swimming Membership**

## Bondi Icebergs Club Limited (ABN 22 263 683 268)

Admission as a Swimming Member of Bondi Icebergs Club Limited (ABN 22 263 683 268) (**Club**) requires each applicant to meet strict criteria, both upon admission and on an ongoing basis.

Failure by a Swimming Member to meet any of these requirements, could lead to suspension or expulsion from the Club and cessation of rights and benefits, including use of Club facilities such as the swimming pool, bar and bistro areas.

## MEMBERSHIP APPLICATION FEES, RIGHTS AND BENEFITS

Prior to completing an application for Swimming Membership, applicants must read and agree to the 'Swimming Club Rules and Expectations', including the swim participation requirements.

Prior to admission, applicants for Swimming Membership are required to undertake an induction, which includes a swim trial. Applicants are required to attend the full Induction Day.

Applicants who first meet all the other criteria are required to pay a first year membership fee **<u>\$250</u>**, payable on Induction Day, as part of the membership admission process.

Swimming Members' membership is valid until 31 March each year, regardless of the date of admission.

Swimming Members have, subject to the constitution of the Club, the right to:

- receive notices of, attend and be heard at general meetings of members of the Club; and
- vote at general meetings of the Club, including in relation to director elections; and
- stand for election as a director of the Club (provided he or she has been an Active Swimming Member for at least 12 months).

Your membership this year provides access to a range of benefits, which currently include:

- unlimited access to the swimming pool and sauna for the period of membership;
- discounts on drink purchases;
- the ability to accrue loyalty points on food purchases; and
- the ability to sign in up to six guests into the registered Club per visit.
